"(4) THAT every shareholder of the Company entitled to vote at an election of directors has the right to cast thereat a number of votes equal to the number of votes attached to the shares held by him multiplied by the number of directors to be elected, and he may cast all such votes in favour of one (1) candidate or distribute them among the candidates in such manner as he sees fit, and that, where he has voted for more than one (1) candidate without specifying the distribution of his votes among such candidates, he shall be deemed to have divided his votes equally among the candidates for whom he voted;"

ii) to provide for a minimum of three directors and a maximum of seven directors.
